As per the revised Worknorms 12 Urban Sections, 63 Rural Sections and 5 Hill Sections totally 80 Sections are admissible in Dindigul EDC. 12 Urban Sections, 59 Rural sections, 5 Hills sections and 7 Supernumerary Sections (Urban - 1 and Rural - 6) are existing in Dindigul EDC. Therefore 1 Urban Section and 2 Rural Sections have to be abolished in Dindigul EDC. As per the Orders issued in Para 3 (ii) & (iii) of the Work norms (Per.) FB TANGEDCO Proceedings No.8, (Sectt. Branch), dated 02.03.2018, there shall not be any retrenchment/reversion consequent on the present revision of work allocation. Hence the 3 (1-Urban and 2-Rural) Sections which have to be abolished may be treated as Supernumerary Sections and the Supernumerary Sections will be adjusted in future sanction of Sections. Due to introduction of new worknorms, 12 Urban Sections, 63 Rural Sections, 5 Hill Sections and 3 Supernumerary Sections (Urban -1 and Rural - 2) may be continued in Dindigul EDC.
