AFFIDAVIT OF A. SEKKIZHAR

I, A. Sekkizhar, S/o. M.Appasamy, aged about 52 years, residing at TNEB Quarters, No.144, Anna Salai, Chennai-600 002, do hereby solemnly affirm and state as follows:

- 1. I state that I am the General Secretary of the Petitioner Union herein and I am well acquainted with the facts of the case.
- 2. I state that I am filing this Writ Petition praying to quash (Per)FB TANGEDCO Proceedings No.8 dated 02.03.2019 creating 5000 new posts of Gangman, Senior Gangman and Chief Gangman; (Per)FB TANGEDCO Proceedings No.10 dated 06.03.2019 issuing amendment to the TNEB Service Regulations with regard to the mode and method of recruitment and other qualifications and rights, issued by the 1st Respondent; the Notification No.1/2019 dated 07.03.2019 calling for applications for appointment in 5000 newly created posts/vacancies of Gangman by direct recruitment, through online mode and the corrigendum notification dated 08.03.2019 issued by the 3rd Respondent and for a consequential direction to the Respondents to absorb the services of the serving contract labourers as Assessor/Field Assistant by retaining the post of Assessor/Field Assistant the next promotional posts.
- 3. I state that our Union is a trade union registered under the Trade Unions Act 1926, with Registration No.3600/CNI. Pursuant to the interim direction of this Hon'ble Court, we were

permitted to participate in the settlement talks regarding wage revision and other conditions of service which resulted in signing of a 12(3) Settlement dated 22.02.2018. Further, this Hon'ble Court has also issued directions to verify the membership of our Union and to grant us recognition on par with the 17 unions, if the number of membership of our Union is equal or more than any of those unions.

- 4. I state that as per the Form-E returns filed by our Union on 27.03.2019 before the Registrar of Trade Union, Chennai-18, the total membership of our union during the end of the year 2018 was 10310. Out of these 10310 members, ____ are contract labourers and they are working in various sections and circles of the 1st Respondent Corporation.
- 5. I state that the Tamilnadu Electricity Board was created under the Electricity Supply Act, 1948 and it was catering to the need of electricity in the entire state of Tamilnadu.
- 6. I state that however the said board was bifurcated and were created into two new companies namely the 1st Respondent herein and Tamilnadu Transmission Corporation Limited under Section 617 of the Companies Act. The 1st Respondent is wholly owned by the Government of Tamilnadu and it is 'state' within the meaning of Article 12 of the Constitution.
- 7. I state that the conditions of service of the workmen are governed by various settlements, awards, certified standing orders and the Tamilnadu Electricity Board Employees Service Regulations. The Service Regulations were framed and notified under Section 79 (c) of the Electricity Supply Act, 1948.
- 8. I state that originally all the generation, transmission and distribution of electricity was vested with Tamilnadu Electricity Board. After creation of the 1st Respondent Corporation, generation and distribution of Electricity has come under the control of the 1st Respondent and the transmission is vested with the TANTRANSCO.
- 9. I state that originally, apart from regular permanent workers, the Tamilnadu Electricity Board was employing Nominal Muster Roll employees (NMRs) and Temporarily Casual Labourers (TCLs) for carrying out the regular, permanent and perennial work which were to be carried out by regular/permanent employees. They were all absorbed and regularized by the Board only due to the persistent demand made by the Unions and by entering into settlements with the unions and by issuing board proceedings and by creating new/supernumerary posts.
- 10. I state that however, the electricity board after absorption of the above categories of NMRs and TCLs, started employing workmen in the name of contract labourers only to exploit them with cheap and less wages. Based on the demands made by the workmen and the unions for regularization and absorption of those contract labourers, the Government of India issued G.O.No.950, Labour and Employment Department dated 08.08.1990 and issued a notification abolishing contract labour system in 19 works and processes.
- 11. I state that in the meantime, the Board prescribed ITI as the qualification for appointment to the post of Helper. The matter was taken to the Hon'ble Supreme Court against such amendment and for absorption of contract labourers. The Hon'ble Supreme Court appointed the retired judge of the Hon'ble Supreme Court the Hon'ble Mr. Justice V. Khalid to submit a report with regard to the absorption of contract labourers. Accordingly the Hon'ble Mr. Justice

- V. Khalid submitted a report for absorption of 18000 contract labourers without reference to the above newly prescribed qualification of ITI and also without reference to their age and based on their experience. The said report was accepted by the Hon'ble Supreme Court.
- 12. I state that however, only the members of the three unions were considered for absorption in the above report which was accepted by the Hon'ble Supreme Court. Though the absorption was to be completed by 1993, the Board completed the process of absorption of the contract labourers only at the end of 1998.
- 13. I state that therefore whenever the workmen who were employed as contract labourers have demanded for their absorption, they assured that their demand would be considered by them after the process of absorption of contract labourers who were covered by the above report was over.
- 14. I state that accordingly, the Board issued B.P.Nos.16 and 17, dated _____ for abolition of contract labour system in all four thermal power stations owned by them on and from 01.05.1999 and for absorption of all the contract labourers who were already working in those power stations, either in the power station in which they were already working or in the nearby distribution circles, with effect from 01.05.1999.
- 15. I state that the board also issued similar proceedings in 1999 and 2005 for abolition of contract labourer system and for absorption of contract labourers who were working in Hydro and Gas Turbine Power Stations.
- 16. I state that so far as the contract labourers who were working in the distribution circles, a number of employees approached the authority under the Tamilnadu Industrial Establishments (Conferment of Permanent Status to Workmen) Act, 1981 under Section 3 (1) and got orders for their permanency from the date of completion of 480 days from the date of their joining.
- 17. I state that in the meantime, the Board itself undertook identification of contract labourers and in fact identified some of the contract labourers as on 08.08.1998. Finally, the Board entered into a settlement dated 10.08.2007 for absorption of 21600 contract labourers in a phased manner and based on their qualifications.
- 18. I state that when the above settlement was put to challenge, the same was upheld by the Hon'ble Division Bench of this Hon'ble Court in a judgment reported in 2009 (4) MLJ Page 472. The Board also issued B.P.Nos.41, 42, 43, 44 and 45 dated 06.09.2007 for implementation of the above settlement dated 10.08.2007 by creating the posts of Mazdoor Grade-II, Helper Cum Meter Reader and Assessor Grade-II.
- 19. I state that for absorption of the left out contract labourers whose cases were not considered in the above settlement, the Board issued B.P.No.9, dated 09.01.2008 and appointed a committee to verify and identify such left out contract labourers for absorption. Therefore, based on the said B.P. also many contract labourers were absorbed.
- 20. I state that however, many contract labourers who were not able to get permanency and absorption as per the above settlement and B.P.No.9 have approached the authorities under the TN Act 46 of 1981 and such cases are pending at various stages and some of the cases are also pending in this Hon'ble Court in Writ Petitions, Writ Appeals and Review Petitions.

Further, the Board itself in some cases where the workmen got orders from the authorities for conferment of permanent status to examine their case and to give them permanency in terms of B.P.No.9 dated 09.01.2008. The said process is not yet over. Apart from continuing the workmen who were already working even prior to the settlement dated 10.08.2007, the 1st Respondent also employed new contract labourers to carry out the work of regular employees, due to the heavy increase in workload and due to non-filling up of various regular posts for a long time.

- 21. I state that therefore all such contract labourers have been demanding for their absorption. In fact, in the settlement dated 22.02.2018, the Board agreed to increase the daily wage of contract labourers from Rs.250/- per day to Rs.380 per day from the date from which the settlement came into effect, w.e.f. 1.12.2015. Further, in the said settlement in the post of Assessor Grade-II and Mazdoor Posts were agreed to be merged with Assessor and Field Assistant respectively from the date of settlement. Therefore, after the date of settlement dated 22.2.2018 the entry level posts in RWE categories are Assessor and Field Assistant and there is no posts below those two posts after 22.2.2018. Further, in the settlement the staff pattern and workload has also been agreed to and determined for each section in different areas. Similarly, duties and responsibility and revised work norms for each posts in RWE categories were also fixed in the settlements. Further, the levels of pay for workmen were also fixed in Part-II of the Appendix to the settlement. It was also agreed to reduce the period of training uniformly to three months with time scale of pay for all new appointments and recruitments at the entry level categories. Further, he was also agreed to decide all other issues on merits on case to case basis, including the issue regarding absorption of contract labourers.
- 22. I state that our Federation held demonstration at the front of all Circle offices throughout Tamilnadu on 2.5.2018 demanding for absorption of all contract labourers and to make all the part time sweepers as full time workers.
- 23. I state that in our Federation's State Conference which was held in Chennai on 27.12.2018 also, we demanded for absorption of contract labourers and to make part time sweepers as full time employees. Further, during the All India Strike between 8.1.2019 and 9.1.2019 also the same demands were made.
- 24. I state that however, in the above circumstances, the 1st Respondent has issued the impugned (Per) FB TANGEDCO Proceedings No.8, Secretariat Branch, dated 2.3.2019 in for creation of 5000 new posts of Gangman, by abolishing the posts which were lying vacant for more than 3 years and granting approval for surrender of equivalent number posts. In fact, the work sought to be assigned to the Gangman which have been and which are being carried out now by the Field Assistants and Mazdoor Grade-I. Further, only two promotional levels equivalent to Wireman and Line Inspector alone are provided in the said B.P. Further, it is stated that the persons who are going to be recruitment as Gangmen in the newly created posts would be initially placed for training for a period of two years with a consolidated pay of Rs.15,000/-.
- 25. I state that pursuant to the above order the 1st Respondent issued the impugned order in (Per) FB TANGEDCO Proceedings No.10, Secretariat Branch, dated 6.3.2019 and made amendments to the service regulations inserting the post of Gangman, Senior Gangman

- and Chief Gangman and prescribed the qualifications, mode and method of recruitments and other conditions for recruitment and promotions. They have also prescribed upper age of limit for appointment to the post of Gangman by direct recruitment. Though, the persons having higher qualifications than the prescribed qualification of 5th Standard are made eligible for appointment, they are made in eligible for cadre conversion and appointment by internal selection even they are qualify for such cadre conversion or internal selection for other posts.
- 26. I state that based on the above two proceedings, the 3rd respondent issued the impugned Notification No.1/2019 dated 7.3.2019 calling for application for appointment to 5000 posts of Gangman by direct recruitment. The applications have to be made through online mode by the candidates from the open market and also by the candidate sponsor by the Employment Exchange from 22.3.2019 to 22.4.2019 and the last date for payment of fee is 24.4.2019. The selection is sought to be made based on the physical test, written examination and certificate verification.
- 27. I state that even as per the above two proceedings dated 2.3.2019 and 6.3.2019 only the post of Gangman is created and when there is no post called Gangman Trainee and when the service regulations does not provide for any appointment on consolidate pay and when the settlement dated 22.3.2018 restricts the period of training only to 3 months for appointment to all entry level posts by direct recruitment, that too with time scale of pay, in the above notification dated 7.3.2019, the respondents have called for applications for appointment to the post of Gangman Trainee with a consolidated pay of Rs.15,000/- and fixing the training period as two years.
- 28. I state that the 3rd respondent also issued the impugned Corrigendum to the above Notification No.1/2019 dated 6.3.2019 with regard to the educational qualifications mentioned in Para 5B and also added two more conditions for appointment.
- 29. I state that on coming to know about the Notification, our union wrote a letter dated 7.3.2019 and pointed out that when contract labourers numbering between 5000 to 10000 have been waiting for absorption and when it was assured by the Hon'ble Minister for Electricity that the Corporation would take steps to absorb the services of the contract labourers and when they only stood with the Board during the crises and emergency and acted swiftly during the cyclones warada, thane, ohi and gaja for restoration of electricity and received appreciation and award for the said work and when such creation and abolition of posts would affect the service conditions of the employees, it was not fair to issue the above orders calling for applications for appointment to the posts of Gangman and requested and demanded the respondents to fill up all the vacant posts which were in existence prior to the issuance of the impugned orders by absorbing all the contract labourers who are already in service for long years and to hold talks and settle the issue amicably and not to go on with the recruitment process as per the notification dated 6.3.2019.
- 30. I state that in fact the 3rd respondent based on the orders of the 2nd respondent, issued a proceedings dated 16.3.2019 directing all the Regional and Circle heads to obtain registration certificate as principal employer and the contractors to obtained licences, under the Contract Labour (Regulation and Abolition) Act, 1970 and under the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979. In fact, the area and work

in and for which the contract workmen are employed or sought to be employed are all permanent and perennial nature of work and in places were the regular permanent employees have to be posted and when they are directly employed on piece rate basis and when there is no intermediaries, the respondents cannot change the conditions of service by bringing contractors and asking them to get registration and licence when the existing contract labourers have been employed without any registration or licences.

- 31. I state that our union also sent a letter Commission of Labour on 18.3.2019 and requested to intervene in the matter to stop the recruitment processes based on the impugned orders. However, no reply is received from them. Further, we have also sent a letter to the State Election Commissioner to stop the recruitment processes in view of the election notification for the Parliament and the Legislative Assembly in the State.
- 32. I respectfully submit that therefore, we have no other option or remedy except to approach this Hon'ble Court under Art.226 of the Constitution. We have not filed any other case for the same relief.
- 33. I respectfully submit that the impugned TANGEDCO Proceedings Nos.8 and 10 dated 2.3.2019 and 6.03.2019 issued by the 1st respondent and the impugned Recruitment Notification No.1/2019 dated 7.3.2019 and the Corrigendum issued on 8.3.2019 by the 3rd respondent are liable to be quashed by this Hon'ble Court for the following among other

GROUNDS:

- a) The impugned orders and notifications are arbitrary and violative of Art.14 of the Constitution
- b) I respectfully submit that any increase or reduction in the number of persons employed are to be employed in any occupation or classes or department or shift is a matter covered under Item 11 of the IV Schedule to the I. D. Act. Therefore, before abolishing the existing posts and creating new posts which would adversely and detrimentally affect the service conditions of the workmen, the respondents cannot abolish the posts and create new posts as per the impugned proceedings dated 2.3.2019, without issuing a notice under Section 9A of the I.D. Act. Therefore, the impugned order is nonest, void and in-operative in law.
- c) I respectfully submit that similarly, the post of Field Assistant and Assessor are the entry level posts in RWE/provincial category as per sub-clause 2 of clause VIII of the 12(3) Settlement dated 22.2.2018, read with the workload norms fixed for each section belonging to different areas. Therefore, when the entry level posts in RWE category is only the Field Assistant, on and from the date of settlement, the respondents cannot create any posts below the Field Assistant in RWE category unilaterally and when the settlement is still in force and when it is not modified or replaced by a new settlement. Therefore, the impugned orders are illegal and contrary to the above settlement. In fact, violation of settlement is punishable under section 29 of the I.D. Act. Further, it is also an unfair labour practice prohibited under Section 25(T) and punishable under Section 25(U) of the I. D.Act as per Section 2(ra) read with Item 13 of the V Schedule to the I. D. Act.

- d) I respectfully submit that as per the existing rules, settlements and practice a person who is appointed as Field Assistant in RWE category is not only entitled to further promotions to the posts of Wireman, Line Inspector, Foreman Grade-I and Special Grade Foreman and also when he is eligible to get conversion and appointment by internal selection to any other posts in the services of the Board to which he is qualified, such rights have been taken away by the impugned proceedings dated 02.03.2019 and the avenue of promotion is restricted only upto the level of Wireman.
- e) I respectfully submit that further as per the settlement dated 22.02.2018 since all the posts of Mazdoor categories have been merged with the post of Field Assistant, the entry level scale of pay shall be 18800-59900. However, the scale of pay fixed for the post of Gangman is as applicable to the post of Mazdoor when it has been already abolished and got merged with the post of Field Assistant. Therefore, the Respondents cannot fix Rs.16,200-51500 as the scale of pay for the Gangman.
- f) I respectfully submit that when the training period has been restricted only to two months and that too on time scale of pay after regular recruitment for all entry level post by direct recruitment, the Respondent cannot fix the training period as two years and also they cannot fix consolidated pay, which is contrary to sub-clause 8 of clause-VIII of the 12(3) settlement dated 22.02.2018.
- g) I respectfully submit that as per the said settlement apart from fixing man power norms for each Section in each area based on the number of transformers and consumers, the Respondents have also agreed to sanction additional number of posts for each section based on the increase in the number of transformers and consumers/service connections. When the sections were already functioning with shortage of personnel due to non-filling up of posts and when the Respondents have not given additional posts based on the increase in the number of transformers and service connections, their action in abolishing the post of Field Assistant in RWE category would result in abolition of all other higher promotional posts also to the extent of the number of posts abolished. Therefore, this would result in serious and heavy increase in work load to the existing workmen.
- h) I respectfully submit that further when they have agreed to consider the demand and request for absorption of the existing contract labourers, they cannot go for direct recruitment that too in a lower post with lower scale and with altered conditions of service with less benefits. Therefore, this would not only deprive the rights of the serving contract labourers from getting absorption based on their long and continuous service, it would also result in deprivation of their very employment and they would be replaced by the persons to be appointed by the impugned orders. Hence, the same is arbitrary and violative of Articles 14 and 21 of the Constitution.
- i) I respectfully submit that apart from failing to regularize and absorb them in the existing vacancies before abolition made in the impugned orders by framing a scheme, they have not even given them opportunity and preference to make application for the posts which are sought to be filled up by the impugned orders by relaxing their age and educational qualification.

- j) I respectfully submit that the impugned orders are contrary to and violative of various judgments of the Hon'ble Supreme Court and this Hon'ble Court.
- k) I respectfully submit that when they have been working continuously for years together and when they have completed more than 480 days of service in 24 calendar months, denying them permanency/permanent status and all the privileges as applicable to Field Assistants would amount to unfair labour practice and also it is contrary to Section 3 (1) of the TN Act 46 of 1981.
- I) I respectfully submit that most of the serving employees have already approached the authorities under the TN Act 46 of 1981 and got favourable orders. Either they have filed Writ Petitions to implement the said orders or the Board has filed Writ Petitions against those orders. Further, many cases were already disposed of by this Hon'ble Court to consider the case of the contract labourers in terms of B.P.No.9 dated 09.01.2008 and the process are not yet over. Therefore, without making them permanent based on such orders, going for direct recruitment is illegal, arbitrary and discriminatory.
- 34. I respectfully submit that the impugned orders are ex-facie illegal, arbitrary and have been issued contrary to the statutory provisions and also in deprivation of the livelihood of the existing serving contract employees.

I therefore pray that this Hon'ble Court may be pleased to grant an interim injunction restraining the Respondents and their officials from proceeding further and making any appointment based on and pursuant to the Orders in (Per)FB TANGEDCO Proceedings No.8 dated 02.03.2019 and (Per)FB TANGEDCO Proceedings No.10 dated 06.03.2019, issued by the 1st Respondent and the Notification No.1/2019 dated 07.03.2019 and the corrigendum issued on 08.03.2019, by the 3rd Respondent, pending disposal of the Writ Petition and thus render justice.

For the aforementioned reasons, it is prayed that this Hon'ble Court may be pleased to issue appropriate Writs, Orders or Directions and in particular issue a writ in the nature of CERTIORARIFIED MANDAMUS, after calling for the records pertaining to the Orders in (Per)FB TANGEDCO Proceedings No.8 dated 02.03.2019 and (Per)FB TANGEDCO Proceedings No.10 dated 06.03.2019, issued by the 1st Respondent and the Notification No.1/2019 dated 07.03.2019 and the corrigendum issued on 08.03.2019, by the 3rd Respondent, quash the same and consequently forbear the Respondents from abolishing or reducing any posts, without issuing any notice under Section 9(A) of the I.D. Act and also without holding talks and without entering into any new settlement modifying or replacing the settlement dated 22.02.2018 and in detriment to the interest of the workman and their conditions of service and to absorb the services of the members of our Union who are serving as contract labourers in the existing vacancies in the post of Field Assistant with all consequential benefits, award costs and thus render justice.

Sub: Distribution - Stock of meters - Instructions not being followed - Strict adherence - Instructions issued - Reg.

Based on the request for submission of details regarding requirement of meters for effecting new services, the Chief Engineers have submitte their requirement from which it is noted that around 72,865 nos of single phase meters are required. On contrary, it is ascertained from the IMS package that 8099 nos of DLMS compliance new single phase meters and aroudn 15200 nos of DLMS compliance meters which was allotted for replacement of electro mechanical meters to static meters under IPDS scheme are in stock. Apart from this, around 986 nos second hand tested single phase DLMS compliance meters are also in stock.

It is very much regretted to note that around 15200 meters allotted for replacement under IPDS scheme were neither replaced nor utilized for effecting new services (for which approval could have sought) for the past 3 months. This kind of action is highly deplorable. This would amount to revenue loss to Board and also creates an artificial demand for meters at this critical juncture wherein there is also public unrest due to shortage of meters for effecting new service connections since December 2018 which is being highlighted in the media creating a bad image about TNE in the eye of the General Public.

Time and again in all reviews/discussions it has been emphasized that SEs have to inspect the stores including the pocket stores on a regular basis to weed out unnecessary stock in hand and to provide correct figures of stock so as to take necessary procurement/allotment actions. But, from the above it is observed that the officers have not taken the instrutions saeriously and have not executed it. This is noted with much displeasure.

It is once again reiterated that the officers should inspect the stores including the pocket stores on a regular basis and the materials on stock should be utilized beneficially and also correct figures are provided to this office. Any negligence in future will be viewed seriously and action deemed fit will be taken against the concerned officials.

In view of overgrowing demand in the supply of Electricity new homes, establishment, factories and companies, initial level five workers are required to carry out lot of ground works (viz.) Digging, Erection of Poles and allied Non-Technical works and also during natural disaste due to shortage of hands, the Chief Engineer/Personnel, Administrative Branch has proposed for creation of 5000 new posts of Gangman TANGEDCO by redeploying/abolihing the posts which are lying vacant more than three years, after identifying the samy by the Committee constituted

for the purpose. The Board of TANGEDCO has approved above proposal with a direction to surrender equivalent number of posts.

- 2. Accordingly, sanction is hereby accorded for creation of 5 new posts of Gangman in the Level of Pay of Rs. 16,200-51,500/- in R category (Class-IV Service) in TANGEDCO for a period from the date intilization of the posts upto 28.02.2010, to attend the following works:
 - i) Digging of holes for erection of poles.
 - ii) Transportation of poles physically.
 - iii) Stringing and erection of poles and conductors under the supervising authority.
 - iv) To carry out miscellaneous works as directed by the Section Officer/Supervising authority.
- 3. Further, it is hereby ordered that the persons recruited for the above said newly created post shall be initially appointed as Gangman and they will be placed for training for two years on consolidated pay of Rs. 15,000/- per month. On successful completion of training they will be placed as regular Gangman and the subsequent line of promotion for the said post are detailed below:-

All the Chief Engineers and the Superintending Engineers of TANGEDCO & TANTRANSCO are hereby instructed to ensure the compliance of the following statutory prosions without any deviations.

- 2) TANGEDCO & TANTRANSCO should obtain the Registration Certificate as Principle Employer under Section 7 of the Contract Labour (Regulation & Abolition) Act 1970 from the competent authorities wherever works contracts are being awarded to the contractors (Annexure-A). On receipt of the registration certificate from the competent authorities the Chief Engineer/ Superintending Engineer (Principle Employer) should issue From-V to the contractors (Annexure-B). The contractors who engage workmen for the works should obtain Labour License under Section 12 of the Contract Labour (Regulation & Abolition) Act 1970 and should produce the labour licence copy before executing the works.
- 3) TANGEDCO & TANTRANSCO should obtain the Registration Certificate as Principle Employer under Section 4 of the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1970 from the competent authorities, wherever the other state workers (Migrant Workers) are engaged by the contractors for the works contracts (Annexure-C). The contractors who engage the other state workers (Migrant Workers) for the works should obtain Migrant Labour Licence under Section 8 of the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979 in addition to the labour licence obtained under Contract Labour (Regulation & Abolition) Act 1970 and should produce the migrant labour licence copy before executing the works.
- 4) Whenever there is a change in number of workmen to be engaged by the contractors for the works contracts (or) change in the list of contractors of the registration certificate, necessary amendment application should be submitted immediately to the competent authorities in the prescribed form and the amended registration certificate should be obtained. The contractor should be permitted to execute the works contracts only after submitting the copy of the labour licence certificate under Contract Labour (Regulation & Abolition) Act 1970 and Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979.
- 5)(i) The competent authority to issue registration certificate under the above acts for the Factories registered under the Factories Act, 1948 is the Joint Director / Industrial Safety and Health, department of Industrial Safety and Health. The jurisdiction of the Joint Director / Industrial Safety and Health are listed in the **Annexure-D**. All the Therman/ Gas/ Hydro Power Stations, Workshop circle, RCC/PSC Yards and other premises mentioned in Section 2(m) of the Factories Act, 1948 are defined as "Factory".

(ii) The competent authority to issue registration certificate under the above acts for the Building and Construction works registered under the Building and Other construction Workers (Regulation of Employment and Condition of Service) Act, 1996 is the Joint Director / Industrial Safety and Health / BOCW Department of Industrial Safety and Health. The jurisdictions of the Joint Director / Industrial Safety and Health / BOCW are listed in the **Annexure-E.** "Building or other construction works" means the construction, alteration, repairs, maintenance or demolition of, or, in relation to, buildings, generation, transmission and distribution of power, electric lines, towers, transmission towers and other works mentioned in section 2(d) of the Building and Other contruction Workers (Regulation of Employment and Condition of Service) Act, 1996.

The Chief Engineers and the Superintending Engineers of TANGEDCO & TANTRANSCO under whom the construction works are being executed should also submit an application in Form-I (Annexure-F) for registration of establishments employing building (or) other construction workers under the Building and Other construction Workers (Regulation of Employment and Condition of Service) Act, 1996.

- (iii) The competent authority to issue registration certificate under Contract Labour (Regulation & Abolition) Act 1970 and Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979 for all the other areas of TANGEDCO & TANTRANSCO which are not been registered as Factories under the Factories Act, 1948 (or) As building and construction works under the Building and Other construction Workers (Regulation of Employment and Condition of Service) Act, 1996 is the Deputy Commissioner of Labour Office of the Joint Commissioner of Labour, Labour and Employment Department. The jurisdictions of the Joint Commissioner of Labour are listed in the **Annexure-G**.
